<u>Call to Order</u>. Ms. DeVore called the meeting to order and reminded members of their duty to avoid conflicts of interest and appearances of conflicts of interest under the State Government Ethics Act, in accordance with Chapter 138A of the North Carolina General Statutes, and advised the Board members to notify her immediately if anyone should become aware of a conflict of interest or the appearance of a conflict of interest during the meeting. No conflicts of interest were reported. A quorum was constituted by a roll call taken by Ms. Jenkins.

Ms. DeVore turned the meeting over to Ms. Katziff, Chair of the Nominating Committee, to conduct the election of the Board's 2021-22 officers.

<u>Election of 2021-22 Officers of the Board of Trustees.</u> Ms. Katziff reminded the Board that she, along with Mssrs. Bunker and Klein, had been appointed by former Chair Wilson to serve on the Nominating Committee to bring a proposed slate of officers to this meeting. Ms. Katziff reviewed the process the Committee used to determine the nominations and indicated that at their May 10, 2021 meeting they agreed on the following slate of candidates:
